MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN NFSC AND NADT

National Fire Service College, Nagpur (herein after referred to as NFSC) and National Academy of Direct Taxes, Nagpur (herein after referred to as NADT) desire to promote academic and training interaction/cooperation between the two institutes. The memorandum of understanding (MoU), made on Seventh day of February, 2023 between NFSC and NADT witnessed as follows:

1. Scope

The main purpose of this MOU is to promote an institutional linkage between NFSC and NADT and to explore avenues for possible collaboration in academic areas and training of stakeholders broadly in the area of Engineering and Technology, Taxation, and Functional and Behavioural competencies in which expertise exists and can be mentored by either or both of the two organizations.

2. Joint Research and Collaboration Projects

NFSC Faculty and NADT Faculty may undertake user oriented joint sponsored research projects according to the following terms:

- Project proposals will be formulated jointly by the concerned Faculty of the two organizations.
- Projects would require the approval of both the organizations.
- The income, if any, arising out of such work will be shared by both the organizations on the bases of inputs and the approved norms in each organization. Cost of a project would be calculated on the basis of the input.

3. Sharing of Faculty

Both NFSC and NADT agree to Share faculty for a limited period up to 1 year at a time for the purpose of implementation of joint tasks. Faculty will be treated to be on duty with the parent organization for this period.

4. Sharing of Important Facility

The two organizations agree to share their important R&D facilities.

5. Joint Conference/Workshop/Courses

Both the organizations agree to hold/conduct whenever feasible, joint conferences/workshops/training courses in the areas of mutual interest.

6. Intellectual Property Rights

The intellectual property rights that arise as a result of joint research and collaborative-activity under the agreement will be worked out on a case-to-case basis and will be consistent with officially laid down IPR policies of the two organizations.


