MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is made on 28.07.2023 between National Fire Service College, Nagpur (now referred to as "the Institution") which was established in 1956 and it is one of the allied organizations of Disaster Management Division under the functioning of Director General (Fire Services, Civil Defence & Home Guards), Ministry of Home Affairs, Government of India having its registered office at National Fire Service College, Takli Feedar Road, Rajnagar, Nagpur, Maharashtra- 440013.

and

The Land Port Authority of India (now referred to as "the Authority") which is a statutory authority constituted under the Land Ports Authority of India Act, 2010. The Act empowers the Authority to develop, manage and operate land ports and to regulate the movement of goods and passengers across the international land borders of India, having its registered office at 1st Floor, Lok Nayak Bhawan, Khan Market, New Delhi-110 003

WHEREAS the Institution provides quality education and training to students and professionals in fire safety in fields of study, and the Authority is responsible for developing, managing, and operating land ports across India.

AND WHEREAS both parties recognise the need for collaboration and cooperation in learning and development to enhance the skills and knowledge of employees and stakeholders in the Authority and to support the Institution in delivering relevant and industry-focused education and training programs related to fire safety only.

NOW, THEREFORE, the parties agree to the following terms and conditions:

Objectives of Collaboration:

This collaboration aims to foster and promote learning and development in land port emergency management and operation and to support the Institution in delivering relevant education and training programs.

Scope of Collaboration:

The scope of collaboration shall include, but not be limited to, the following activities:

- Joint development of curriculum and training modules for land port emergency management.
- 2. Exchange of faculty, staff and experts for teaching & training.
- 3. Conduct joint seminars, conferences, workshops, and training programs.
- 4. Sharing knowledge, expertise, and resources to benefit students, professionals, and stakeholders in the land port sector.





- 5. The Authority will help the institution in conducting practical attachment or industrial visit for the professional officer trainees of the various professional courses and B.E Fire Engg. Students which is running in the NFSC.
- 6. The Authority will help the institution in accommodating the employees of LPAI for the fire safety course which is to be held in the NFSC.
- 7. The Institution will only provide the letter of attended fire safety training to the LPAI employee. No separate certificate will be issued.
- 8. Contribution of Parties: Both parties shall contribute to this collaboration in the following ways:
 - i) The Institution shall provide expertise, faculty, and resources for developing and delivering education and training programs.
 - ii) The Authority shall provide support, guidance, and access to resources and facilities and facilitate the participation of its employees and stakeholders in the education and training programs.

Governance and Management:

Financial Management: Nationally Section Affairs Section 11 Section 12 Financial Management: National Management 11 Section 12 Financial Management 12

The Authority will bear the financial expenses of Onsite Training.

The Financial expenses of Officers or staff or NFSC Trainers visiting LPAI various sites for onsite training will be borne by the Authority. (with a reference to the office memorandum No. 19030/1/2017-E-IV of dated 13th July 2017).

The Authority will bear the financial liabilities in accommodating the employees of LPAI for the fire safety course which is to be held in the NFSC Nagpur.

Intellectual Property Rights:

Both parties shall jointly own any intellectual property created or developed because of this collaboration. The parties shall agree on the terms of use, protection, and exploitation of such intellectual property in a separate agreement.

Term and Termination:

This collaboration shall commence on 26.07.2023 and continue for a period of COLLABORATION]. Either party may terminate this collaboration by giving one month written notice to the other party.





Amendment and Variation:

This Memorandum of Association may be amended or varied by mutual agreement of both parties in writing.
