In case of other categories of Persons with Benchmark Disabilities as defined under Section 2 (r) of the RPWD Act, 2016, the facility of scribe will be provided on production of a certificate to the effect that the person concerned has physical limitation to write and scribe is essential to write on his/her behalf, from the Chief Medical Officer/Civil Surgeon/Medical Superintend of a Government Health Care Institution as per proforma available under segment 'Recruitment' followed by the Forms of Certificates (link https://upsc.gov.in/recruitment/recruitment-performas) on Commission's Website.
