In reference to your email dated 24th December 2025 and letter No. 0014/DGR/TRG/SFO/471-01-2026/RES-8 dated 19th December 2025, attention is invited to the nomination of 10 candidates for the 55th External Sub Officers Course scheduled from 12th January 2026 to 28th August 2026. It is to inform in this regard that the confirmation of admission of the nominated candidates is subject to the payment of fees of 10 candidates before the time of reporting.

The requisite fees, comprising tuition, room rent (excluding practical attachment/industrial visit period, which may vary), examination fees, and refundable caution money, are to be paid in advance directly to the allotted State Training Centre (STC) for each candidate prior to course commencement. 

1. KINDLY TAKE A PRINT OF THIS ALLOTMENT ORDER AS NO HARD COPY WILL BE FORWARDED.
2. THERE SHALL BE NO CHANGE OF STC/NFSC. NO COMMUNICATION IN THIS REGARD SHALL BE ENTERTAINED.
3. The Candidate(s) is/are required to produce original certificates in respect of age, educational qualifications and service ID card at the time of reporting to their respective NFSC/STCs as allotted.
4. The Candidates(s) are required to report at allotted NFSC/STCs on or before 11/01/2026 and produce all original certificates/documents to complete the Admission Process during office hours from 10:00 AM to 05:00 PM on 12/01/2026
5. If Candidates fail to report on or before the scheduled dates along with original documents, their admission shall stand cancelled without any intimation to the respective Sponsoring Authority.
6. On completion of the admission process, Hostel Accommodation will be allotted on the same day.
7. **The provisionally admitted trainee officers of all the Professional Courses shall wear the uniform of their respective Fire Services/Organization to which they belong during the entire training period.**
