- (iii) with ten years' regular service in the grade rendered after appointment thereto on a regular basis in level-4 in the pay matrix (Rs.25500-81100) or equivalent in the parent cadre or department.

Note 1: The departmental Stenographer Grade-II in level-4 in the pay matrix (Rs.25500-81100) with ten years' regular service in grade shall be considered along with outsiders. If the departmental candidate is selected for appointment to the post, it shall be treated as having been filled by promotion.




Note 2: The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, the deputationists shall not be eligible for consideration for appointment by promotion.

Note 3: The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not exceed three years.

Note 4: The maximum age-limit for appointment by deputation shall be not exceeding fifty-six years as on the closing date of receipt of applications.
